In the reference first cited, the Project Approval Board – RUSA has sanctioned infrastructure grants to the [5] Universities @ 20 crores each (under component 3). Government have released Rs. 5 crores as 1st instalment in respect of Yogi Vemana University (YVU).

Subsequently, the universities were issued certain instructions to be followed while preparing of the Detailed Project Report (DPR) vide reference second cited.

In response, Yogi Vemana University, Kadapa had furnished the DPR to the Andhra Pradesh State Higher Education Council (APSICHE) vide reference third cited.

Vide reference fourth cited, the APSICHE has forwarded the DPR to the State Project Directorate for release of funds after due scrutiny of the DPR as per the prescribed norms.

Further, in the reference fifth cited, the university has been requested to open a separate Bank account for RUSA funds duly following the RUSA guidelines.

In the reference sixth cited, Government have issued BROs for Rs. 10,00,00,000/- (Rupees Ten Crores) towards implementation of Rashtriya Uchcharat Shiksha Abhiyan (RUSA) during the year 2016-17.

Subsequently, in reference seventh cited, Administrative Sanction Orders have been issued by Higher Education Department, Government A.P.

In view of the above, it is decided to release the grants to Yogi Vemana University.

Therefore, the Secretary, APSCH is requested release an amount of Rs. 5 crores (Five Crores) to Yogi Vemana University (YVU) under "Infrastructure grants (Component 3)" as 1st instalment. (Bank account details are enclosed in annexure).
