The Project Approval Board – RUSA has sanctioned infrastructure grants to the Universities @ 20 crores (under component 3).

The Government of India have released its share through Sanction orders vide reference first cited. In this connection, GoI have released Rs. 6 Crores each as 2nd instalment in respect of **Andhra University (AU) & Yogi Vemana University (YVU)**.

In the reference second & third cited, Government have issued BROs state share included of Andhra University (AU) & Yogi Vemana University (YVU) to each Rs.10Cr. towards implementation of Rashtriya Uchcharat Shiksha Abhiyan (RUSA) during the year 2017-18 which includes grants.


Subsequently, in reference fourth & fifth cited, Administrative Sanction orders have been issued by Higher Education Department, Government A.P.

Hence in reference sixth cited, the sanctioned amount with state share of Rs.52,40,00,000/- (Rupees Fifty Two crores Forty lakhs only) credited in the RUSA CFMS account include AU & YVU Rs.20 Cr. grant.

In view of the above, it is decided to release the grants to **Rs.10,00,00,000/- (Rupees Ten crores only) of Andhra University, Visakhapatnam** and **Rs.10,00,00,000/- (Rupees Ten crores only) of Yogi Vemana University, Kadapa** respectively.

Therefore, it is requested release an amount of **Rs.20,00,00,000/- (Rupees Twenty Crores only) to Andhra University, Visakhapatnam and Yogi Vemana University, Kadapa for each Rs.10,00,00,000/- (Rupees Ten crores only)** under "Infrastructure grants (Component 3)" as 2nd instalment amount.
